Effective November 23, 2010, the Office of the Chief Financial Officer, Finance Office, is reorganized as follows: 1) rename the Administrative Services Group to the Financial and Administrative Services Division; 2) establish the Administrative Services Branch; 3) abolish the Systems Integrity Branch located in the Financial Systems Division; and 4) rename the Certification and System Support Group to Certification and System Support Branch.
