

SUBJECT: Reorganization - National Marine Fisheries Service,  
Greater Atlantic Regional Fisheries

TO: National Marine Fisheries Service, Deputy Assistant  
Administrator for Operations and Administrative

Effective May 15, 2014, the National Marine Fisheries Service,  
Greater Atlantic Regional Fisheries Office (GARFO) is renamed  
from the Northeast Regional Office and reorganized as follows:  
1) establish the Stakeholder Engagement Division; and, 2)  
establish the Information Resource Management Division; 3)  
establish the Analysis and Program Support Division. The  
following will be renamed: 1) Operations Management and  
Information Division to Operations and Budget Division.  
Abolish the following: 1) State, Federal and Constituent  
Programs Office, and Fishery Statistics Office. All of the mail  
routing codes have been changed. The organizations and related  
code structures are revised as follows:
