PRE-DIVE CHECKLIST**1. MISSION SAFETY**

<input type="checkbox"/> Dive objectives and goals are defined, reviewed, and understood by all the divers and support personnel.
<input type="checkbox"/> The Diving Accident Management Plan (DAMP) is posted, coordinated, and reviewed (i.e. chamber availability, evacuation route, etc.).
<input type="checkbox"/> All personnel have been informed of their assigned diving duties.
<input type="checkbox"/> A Pre-Dive safety briefing has been conducted.

2. EVALUATE AND PREPARE FOR POTENTIAL HAZARDS

<input type="checkbox"/> Dive site entry and exit point(s) have been identified and recognized by all divers and support personnel.
<input type="checkbox"/> Maximum depth and bottom time, and minimum cylinder ending pressure limits have been defined for the planned dive.
<input type="checkbox"/> Shifting currents, dangerous marine life, bottom obstructions, entrapment, entanglement, and other physical hazards have been evaluated and discussed.
<input type="checkbox"/> Marine traffic, gear malfunctions, and other mechanical hazards have been evaluated and discussed.
<input type="checkbox"/> The Pre-Dive portion of the Dive Operations Plan - Safe Ship (NOAA Form 57-03-22) has been completed (if applicable).

3. DIVING AND SUPPORT PERSONNEL

<input type="checkbox"/> Each diver is authorized to perform assigned diving duties according to their certification level (e.g. Working Diver, Scientific Diver, Trainee Diver, or Observational Diver).
<input type="checkbox"/> Each diver is qualified to complete their assigned underwater tasks safely.
<input type="checkbox"/> Support personnel understand all emergency recall and diver hand signals, and can offer immediate assistance in case of an emergency.
<input type="checkbox"/> A repetitive dive designation has been determined for each diver for any dive made within the previous 12 hours.

4. EQUIPMENT

<input type="checkbox"/> All support equipment (boats, compressors, oxygen kits, tools, etc.) to be used will be operated by trained personnel.
<input type="checkbox"/> All dive techniques to be used are safe, authorized, and appropriate for the task.
<input type="checkbox"/> All tools to be used are appropriate for the task.
<input type="checkbox"/> A complete diving first-aid kit, first-aid handbook, oxygen resuscitator, divemaster kit, "Alpha" flag, Diver Down flag, and a complete set of no-decompression dive tables for air and Nitrox are on site.

<input type="checkbox"/> Post dive portion of the Dive Operations Plan - Safe Ship (NOAA Form 57-03-22) has been completed (if applicable).
<input type="checkbox"/> All personal dive and support equipment is thoroughly cleaned and properly stowed.
<input type="checkbox"/> A Post-Dive debriefing and critique of operations has been conducted, including procedures for flying after diving (if applicable).
